

GENERAL TERMS OF USE

General terms of use for registration and cancellation of registration for Kids Conference event.

1. General

General terms of use apply for the process of registration and cancellation of registration for Kids Conference event.

This general terms of use apply for all events (conference, seminars, workshop, etc.) that will take place during the Kids Conference. The conference is organized by Apel PR (**hereinafter: Organizer**)

General terms of use are equal for all applicants and for all events, except if it is stated differently in registration form for an individual event.

These general terms of use are a part of each registration form for each event, the manner of registration does not matter. Each applicant with the registration itself unconditionally accepts these general terms of use.

Some changes may occur to these general terms of use. The updated version of the terms is always published on: www.kids-conference.com.

2. Registration and Registration fee

Registration form

Registration is possible with fulfillment of the web registration form, published on web site: www.kids-conference.com, or by email to the address: info@kids-conference.com. In a case of free accommodation you can fulfill the registration form at the event itself.

Information on the registration form

With each registration, disregard the manner of the registration, you have to provide following information:

Name and a surname of the applicant, the number of applicants (the number of children and number of the adults), information about the payer: company, address, ID for VAT and registration number*, telephone number, fax, email*, stamp and a signature of the applicant*

(information marked with * is mandatory. You can find more detailed explanation about protection of personal data in paragraph 6 of these general terms)

Payment of the registration fee

On registration form and/or on the web site of each individual event you can find the amount you have to pay as a registration fee. There is also published all information about possible discount.

The organizer will issue an invoice to an address stated in registration form. The discount will be recognized only if the organizer receive fulfilled registration form until the date stated on web site and/or on the registration form

3. Liability of the organizer

The organizer is not liable for any damages that may occur during the conference, during the traveling to the conference or traveling from the conference and during the time of the accommodation in the hotel.

4. Cancellation of the registration

Cancellation of the registration after payment of the registration fee is no longer possible. Registration fee must be paid within 5 days after receiving the registration confirmation by the organizer.

If the applicant can not attend the conference, the applicant can be replaced by somebody else.

5. Cancellation of the event by the organizer

Organizer retains its right to change the date, location, content of the event and the right to cancel the event as a whole or each individual event.

In a case of cancellation of the event by the organizer, organizer will return the money within 14 days after the day that event was supposed to start.

6. Protection of the personal data

Organizer provides the highest standards of protection for personal data and commits itself to use the personal data collected only for the purpose of analysis of the information about the participants of the events, marketing research and presentation of the products and services provided by organizer, t. e. Apple PR. The organizer binds itself that it will not forward the data collected to a third party. With a signature the applicant accepts use and processing of the personal data he provided on the registration form for the purpose stated above. The applicants can demand that the organizer ceases to use and process their personal data at anytime. The applicants have the right to access the personal data that was gathered about them. The applicant can demand the insight, correction, change and update of its personal data. Organizer is on the demand of the applicant obliged within 15 days prevent any use of the applicants personal data. Organizer is also obliged, within 5 days, after it prevented the use of personal data of the applicant inform the applicant about the cessation of a use of personal data. The organizer carries all costs caused by this actions.
